The platform seeks to enhance businesses' comprehension of their suppliers' carbon emissions levels, fostering an environment that encourages suppliers to actively reduce their carbon footprint. This aligns with the ambitious objective set by the Hong Kong government to attain carbon neutrality by 2050.

The disclosure of Scope 3 carbon emissions data has emerged as a catalyst for promoting sustainable development collaborations among enterprises, thereby driving further progress towards low-carbon transformations. In the realm of sustainable procurement, meeting the disclosure requirements outlined in ESG reports by the HKEX will necessitate suppliers capable of providing low-carbon emission services or products, accompanied by comprehensive carbon emissions data. These factors will become indispensable criteria for listed companies when selecting their suppliers."
